REGISTER

Register & receive your reference code

Partner accounts are verified, so registration is a two-part process: first you register your business, then you activate your portal with the reference code we email you.

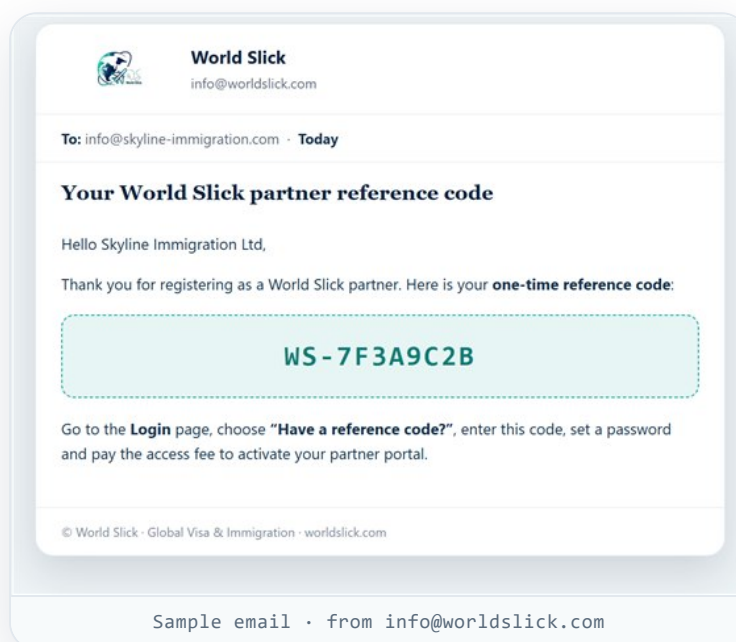
Open **Partners** (or **Consultation** → **Consultant**). World Slick then emails your one-time **reference code** to your official inbox — see the next page.



YOUR REFERENCE CODE

Received on your official email

Moments after you register, World Slick emails your one-time reference code to your official inbox — this is what it looks like.



Keep your reference code safe. It is single-use and required to activate your portal. If you don't see it, check spam or contact **consultants@worldslick.com**.



ACTIVATE

Activate your portal & manage clients

Once you have your reference code, activation takes a couple of minutes — then your consultant dashboard is ready.

Activate with your reference code

On the **Login** page choose “**Have a reference code?**” Enter your **reference code**, set a secure **password**, and pay the **one-time partner access fee** by PayPal. Your partner portal activates instantly.

Use your consultant dashboard

Inside your portal you can view your **signed agreement & terms**, your fee status and reference, and your **Client Applications** table — client name, passport number, application number, visa & destination, and live status.

Sign in any time

Return to the **Login** page and sign in with your **email or reference code + password**. Your clients and progress are always saved.
